**DRAFT RESOLUTION OF THE COUNCIL CONCERNING THE ACCESSION OF THE SLOVAK
REPUBLIC TO THE CONVENTION ON THE OECD AND ENTRY INTO FORCE OF THE
AGREEMENT ON THE PRIVILEGES AND IMMUNITIES GRANTED TO THE ORGANISATION**

1. By its Decision dated 28 July 2000, the Council invited the Slovak Republic to accede to the Convention on the Organisation for Economic Co-operation and Development, in conformity with the conditions set out in the Agreement signed on 28 September 2000.
2. The Secretary-General has been informed that the Slovak Republic deposited its instrument of accession to the OECD Convention with the French Government, depositary of the Convention, on 14 December 2000. In accordance with Article 16 of the Convention, the accession of the Slovak Republic to the Convention on the OECD has taken effect on the same date and the Slovak Republic became a Member of the Organisation on that date.
3. Furthermore, the Embassy of the Slovak Republic has informed the Secretary-General on 5 December 2000 that the constitutional requirements for the entry into force of the Agreement between the OECD and the Slovak Republic on privileges and immunities granted to the Organisation have been completed. Pursuant to its Article 21, the Agreement has therefore also entered into force on 5 December 2000.
4. The Secretary-General invites the Council to adopt the following draft conclusions:

THE COUNCIL

- a) noted document C(2000)238;
- b) adopted the draft Resolution concerning the accession of the Slovak Republic to the Convention on the OECD and the entry into force of the Agreement between the OECD and the Government of the Slovak Republic on Privileges and Immunities granted to the OECD;
- c) agreed to the declassification of this Resolution.

DRAFT RESOLUTION OF THE COUNCIL

**CONCERNING THE ACCESSION OF THE SLOVAK REPUBLIC TO THE
CONVENTION ON THE OECD AND THE ENTRY INTO FORCE OF THE AGREEMENT
BETWEEN THE OECD AND THE GOVERNMENT OF THE SLOVAK REPUBLIC
ON PRIVILEGES AND IMMUNITIES GRANTED TO THE ORGANISATION**

The Council,

Having regard to Article 16 of the Convention on the Organisation for Economic Co-operation and Development of 14th December 1960 (hereinafter “the Convention”);

Having regard to the Agreement on the invitation to the Slovak Republic to accede to the Convention signed on 28 September 2000;

Considering that the Instrument of Accession of the Slovak Republic to the Convention was deposited on 14 December 2000 with the French Government, depositary of the Convention;

Considering that the Slovak Republic has informed the Organisation on 5 December 2000 of the completion of the constitutional requirements necessary for the entry into force of the Agreement between the OECD and the Government of the Slovak Republic on Privileges and Immunities granted to the Organisation, in conformity with Article 21 of that Agreement;

NOTES that the accession of the Slovak Republic to the Convention has taken effect on 14 December 2000;

NOTES that the Agreement between the OECD and the Government of the Slovak Republic on the privileges and immunities granted to the Organisation came into force on 5 December 2000.
