### Membership

The Committee, which was in practice open to all Member countries of the Organisation since 1987, became formally a plenary body in 1997 [C/M(97)2, Item 19].

The Resolution adopted by the Council on 12th October 1971 [C(71)191] and modified on 12 September 1991 [C(91)137], provides that the Advisory Board is open to all the countries participating in the Centre. At present all Member countries (including Korea since 23 April 1992) participate, except Australia, New Zealand, Turkey and Hungary (who have never done so), and the United Kingdom, which withdrew from the Centre as from 1 January 1996, and the United States, which withdrew as from 1 July 1997.
