73. ASSESSMENT OF THE NEW GOVERNANCE SYSTEM

THE COMMITTEE

- a) noted Room Documents Nos. 1 and 2, Room Document No. 2 of 20 April and the introductory remarks by the Chair and the Secretariat;
- b) noted the comments and questions by Delegations and the replies by the Chair and the Secretariat;
- noted that the discussion on the proposals set out in Room Document No.1 concerning the mandates of Standing Committees would be pursued at its next session, possibly with the participation of the Chairs of the Budget and External Relations Committees;
- d) noted also that the Secretariat will submit for the next session a note with proposals on those "normal cases" which could possibly enter into the category of special cases.

74. PREPARATION OF THE 27-28 MAY MINISTERIAL COUNCIL MEETING: LATEST DEVELOPMENTS

- d) noted the proposal by Italy to pursue the discussions on the MCM Output document at an open-ended meeting at the Italian Delegation on 20 May, with a view to presenting an agreed text to Council on 21 May;
- e) noted also the remarks by Italy regarding the on-going consultations with the five Enhanced Engagement countries on a separate MCM text, and that the issue would be discussed further in Council on 21 May;

- f) noted that an advance copy of document CES(2010)6 on organisational aspects of the MCM was posted on the Council Extranet on 11 May and that the document would be amended in light of the comments made at a meeting with Liaison Officers on 19 May;
- g) noted Deputy Secretary-General de Geus's remarks on some procedural aspects, notably that the brochure containing the core MCM documents would be presented to Delegations on 20 May, and that the themes for the breakfast on 28 May would be Enhanced Engagement, Accession and the Organisation's 50th Anniversary.
