## Participants

Capital-based delegates (senior-level) of the development and trade policy communities in OECD Member States, International Financial Institutions (IMF, WB), Members of the WTO Secretariat, Chair of the WTO Task Force on Aid for Trade (Ambassador Mia Horn af Rantzien) and UN Agencies participating in the Integrated Framework (UNDP, UNCTAD, ITC).

## Focus

The joint meeting will address the Hong Kong WTO Ministerial Declaration call for the expansion of aid-for-trade to help developing countries benefit from WTO agreements and more broadly expand their trade. It is within this context that the OECD Development Assistance Committee and Trade Committee have examined the following three issues:

1. How much aid do donors already provide in support of trade;
2. How effective are these programmes; and,
3. How to make aid-for-trade an effective tool for helping developing countries to fully benefit from trade liberalisation and WTO Agreements.

In addition, participants will be requested to provide comments on the proposed 2007/8 Joint Programme of Work and Budget (Room document 2), and the proposed policy dialogue (Room document 1).

Although trade facilitation will not be a focus at this meeting, it will be important to keep in mind that the on-going negotiations in Geneva on trade facilitation are closely related to the aid-for-trade agenda.

## Expected Output

- Endorsement of the joint DCD/TD contribution to the WTO Task Force on Aid-for-Trade.
- Consideration will be given to issuing a joint statement by the co-Chairs regarding the outcome of the meeting if participants find it useful.
- Guidance on possible collaborative DCD/TD work on trade and development in the context of the 2007/8 PWB.
