Reporting contributions to trust funds managed by multilateral institutions. Guidance document

This cancel and replace version is to address formatting issues in the document posted earlier on 8 June 2023.

In July 2021, the WP-STAT approved via the written procedure a proposal containing co-operation modalities for reporting contributions to multilateral institutions and trust funds [see [DCD/DAC/STAT\(2021\)12/REV1](#)]. These changes take effect on 1 January 2022, for the reporting of 2021 data. Countries unable to implement the new modalities in 2022 can implement them in 2023.

This note provides guidance for the reporting on contributions to trust funds managed by the United Nations System, the Asian Development Bank, the Inter-American Development Bank, the African Development Bank and the European Investment Bank, applying the approved co-operation modalities.

This guidance note cannot be considered an exhaustive document. The Secretariat will progressively update the guidance with additional information for contributions to trust funds managed by other multilateral institutions.

Reporting contributions to trust funds managed by multilateral institutions. Guidance document

Introduction

1. At the WP-STAT meeting held on 16-18 June 2021, the Secretariat presented a document on the implementation of new development co-operation modalities for trust funds managed by multilateral institutions [DCD/DAC/STAT(2021)12]. The proposal was slightly amended as per comments received during the meeting and circulated for approval under the written procedure on a non-objection basis. The revised proposal DCD/DAC/STAT(2021)12/REV1 was approved on 8 July 2021, to take effect on 1 January 2022 for the reporting of 2021 data. Countries unable to implement the new modalities in 2022 can implement them in 2023.

2. This note provides guidance for the reporting on contributions to trust funds managed by the United Nations System (see Annexes A and B), the Asian Development Bank (Annex C), the Inter-American Development Bank (Annex D), the African Development Bank (Annex E) and the European Investment Bank (Annex F), applying the approved co-operation modalities. This guidance cannot be considered an exhaustive document. The Secretariat will progressively update this document with guidance on trust funds managed by other multilateral institutions. The note was updated in June 2023.
