2000 Development Co-operation Report

The Development Co-operation Report will be issued this year as separate chapters (see attached outline/schedule). Two chapters, Chapter 4 [DCD/DAC(2000)21/CHAP4] and Chapter 6 [DCD/DAC(2000)21/CHAP6], have already been circulated, requesting comments by 16 and 18 October respectively. Chapters 1, 2, 3, and 5 will follow before the end of October (approximate dates indicated on the attached schedule). Comments should be sent to the chapter co-ordinators listed as contacts on the document cover pages.

The individual chapters will subsequently be updated to incorporate comments from Delegations and a revised compound document of the Report [DCD/DAC(2000)21/PROV] will be circulated before declassification at the Council meeting on **24 November**.
