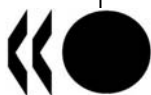

9:30 – 11:00 **The role of Parliament in the Approval and Oversight of Fiscal Stimulus Packages and Strategies to Reduce Fiscal Deficits**

As the full onset of the financial crisis was being realized at the start of 2009, many countries decided to pursue aggressive fiscal stimulus. In addition to monetary and regulatory efforts, most countries pursued discretionary fiscal stimulus through a combination of spending and tax mechanisms. There are legitimate questions about the effectiveness of fiscal stimulus. Keeping in mind that any test of the impact of stimulus relies crucially on the counterfactual of what would have happened had there not been a stimulus, have these policies been successful? How quickly did tax and spending measures hit the real economy and did benefits reach those most in need? What was the relative effectiveness of tax cuts versus spending in stimulating domestic demand? Has fiscal stimulus damaged longer-term fiscal conditions? What approaches has parliament used to monitor execution of stimulus packages and what has been the role of parliamentary budget officials in supporting them?

Political debate has moved swiftly on from the need for a fiscal stimulus to a recognition that fiscal deficits have grown substantially and need to be reduced. The new OECD report on *Restoring Public Finances* notes that in many OECD countries, fiscal deficits and debt are large and fiscal consolidation is inevitable. How quickly should deficits be reduced and how can they be reduced? What are the various requirements, instruments, institutional arrangements, and timing issues being considered in OECD countries and how are parliaments playing a role in these discussions?

Following lead presentations, by **Mr. Bob Sunshine**, Deputy Director, Congressional Budget Office (CBO), United States, and **Dr. Marc Shattenmann**, Senior Officer, Budget

Committee Secretariat, German Bundestag, the floor will be opened for Delegates to discuss current debates and experiences in their own countries.

11:00-11:30 ***Coffee Break***

11:-30-13:00 **Committee Structures for Budget Approval and Oversight**

This session will examine the potential impact of committee structures on the budget approval and oversight process. Several broad models exist (with some variations across parliaments) for committee involvement in the budget process. The Budget/Finance Committee may be the sole budgetary decision maker. Alternatively, a more hierarchical model may exist where sectoral committees make recommendations to the Budget/Finance Committee which coordinates their input and may also set them binding ceilings. In others, budgetary decision making is decentralized giving sectoral committees the responsibility for considering appropriations for each respective sector. What are the relative strengths and weaknesses of such models? How might these models effect public spending and fiscal discipline? In addition, how might committee structure impact how parliament plays its oversight role throughout the fiscal year?

Following a lead presentation by **Mr. Joachim Wehner**, the floor will be opened for Delegates to discuss current debates and experiences in their own countries.

15:30-18:00 **Roundtable on Recent Parliamentary Budgeting Developments**

This session is designed for Delegates to make informal presentations and exchange information on recent budgeting and public expenditure developments and reforms in their countries from a parliamentary perspective. Participants at this year's meeting are invited to speak briefly on recent developments and reforms that may be of interest to others. Given constraints on time, participants may also wish to provide short, written statements to supplement their presentations.

Special time will be allocated during this session to countries that did not participate in last year's meeting in order for them to profile their respective parliamentary budget institutions.

9:00-10:45 Parliamentary Budget Offices and Fiscal Councils – New Institutions and Challenges

Since the last meeting of the PBO Network several new institutions were set up or are in the process of being set up. The United Kingdom established the Office for Budget Responsibility in May 2010 to make an independent assessment of the public finances and the economy for each Budget and Pre-Budget Report. The Australian Parliament recently concluded hearings on setting up a Parliamentary Budget Office. These new institutions may struggle to assert their independence. Budget cuts imposed on the Hungarian Fiscal Council have effectively abolished it and both the Swedish Fiscal Policy Council and the Canadian Parliamentary Budget Officer have been threatened with budget cuts following critical analysis.

This session will be chaired by **Prof. Lars Calmfors**, Chair, Swedish Fiscal Policy Council. Following lead presentations by Prof. Lars Calmfors, Chair, Swedish Fiscal Policy Council, **Mr. Robert Chote**, Chair, Office for Budget Responsibility (OBR), and **Mr. George Kopits**, former Chair of the Hungarian Fiscal Council, the floor will be opened to a general discussion among Delegates.

10:45-11:15 *Coffee Break*

11:15-12:30 The Impact of Parliamentary Budget Offices

During discussions last year, Delegates expressed an interest in specific case studies that demonstrate the impact of the work of Parliamentary Budget Offices. Following a lead presentation by **Mr. Bob Sunshine**, Deputy Director, Congressional Budget Office (CBO), United States, on the impact of CBO analysis on the debate on the United States new health care legislation, the floor will be opened to a general discussion among Delegates.

12:30-14:00 *Luncheon followed by a guided Tour of Parliament Building*

14:00-15:30 Interim Reporting Practices and Legislative Oversight in OECD Countries

Timely and useful data are critical to legislative oversight. Countries differ in terms of the content, format, and frequency, of interim reports, as well as the interpretive support available to the legislature when scrutinizing such reports. A key aspect of several stimulus/recovery packages has been additional public interim reporting on spending, outputs and anticipated results. Most prominent among these is the US government's recovery.gov Web site. This session will look at the current practices and emerging trends regarding interim reporting practices by OECD governments to the legislative branch and the public. It will consider whether differences in reporting requirements are correlated with differing uses of the data by legislatures, and whether more robust reporting requirements coincide with greater in-year legislative review and decision-making.

Following a lead presentation by **Mr. Kevin Page**, Parliamentary Budget Officer, Canada, the floor will be opened for Delegates to discuss current debates and experiences in their own countries.

15:30 – 16:00 Report by the OECD Secretariat

This session is designed to update participants on current and future projects by the OECD in the field of budgeting and public expenditures. It is also an opportunity for participants to identify emerging priority areas for future work, the nature of their interest in the subject and their willingness to participate in particular studies.

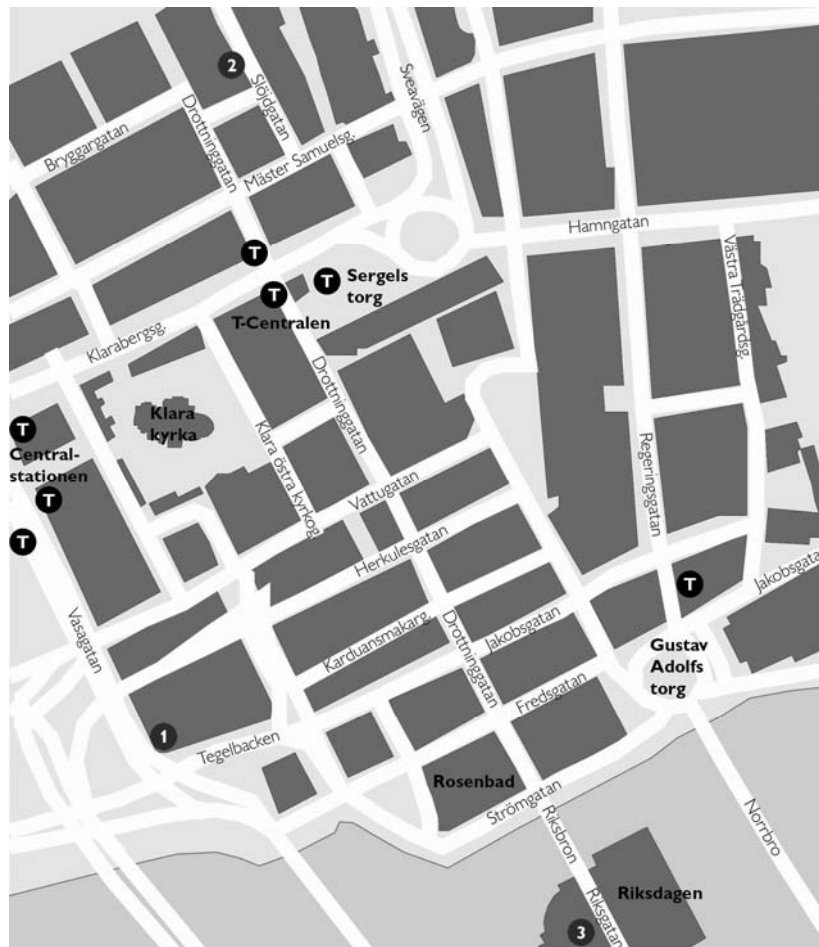
