## REFINING TOSSD DEFINITIONS AND REPORTING METHODS

### I. Background

1. At the May 2024 meeting, the IFT General Assembly discussed a series of edits to the TOSSD Reporting Instructions, which were subsequently approved by the Steering Group. This paper invites Steering Group members to discuss and agree on proposed edits that remained pending in relation to: (i) language on the ‘pivotal partner’ of triangular/trilateral co-operation; (ii) tracking multilateral organisations’ support to South-South co-operation; and (iii) classification, as either pillar II.A or II.B, of core contributions to international organisations (multilateral organisations, international NGOs and PPPs). The paper also proposes complementing the guidance on ‘global health’ with additional examples of diseases prevalent in developing countries. The proposed edits are presented in sections II, III, IV and V below.

### II. Language on the ‘pivotal partner’ of triangular/trilateral co-operation

2. At the [May 2024 meeting of the IFT General Assembly](#), under item ‘experiences with TOSSD reporting’, participants discussed the reference to the ‘pivotal partner’ of triangular/trilateral co-operation in the Reporting Instructions. Several participants noted that the concept was difficult to apply and incoherent with the horizontality principles of South-South co-operation (SSC). It was agreed that the Secretariat would explore revising the language concerning the pivotal partner, which currently appears in paragraphs 43-44 and 122, as well as in figure 4 of the TOSSD Reporting Instructions.
3. The Secretariat consulted with the members who had commented on the pivotal partner language, specifically Brazil, the European Commission and Mexico. Additionally, Chile, which was not present at the May 2024 meeting but showed interest in the topic, was consulted. Based on these discussions, the Secretariat proposes refining the language on triangular co-operation as follows (see ~~strikethrough~~ indicating deleted text and underlining for new text):

“Triangular co-operation (also referred to as trilateral co-operation) involves a partnership among at least three partners, where ~~three~~ the following main roles can be identified as follows (Figure 4):

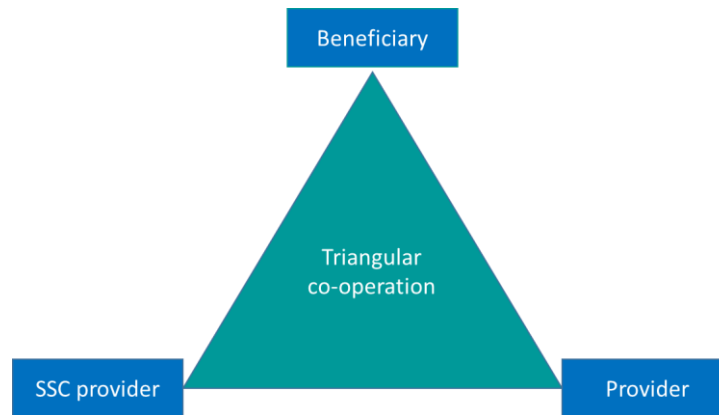
- The beneficiary partner, which is a TOSSD recipient that requests support to tackle a specific development challenge.
- ~~• The pivotal partner that has relevant domestic experience in addressing the issue in a context similar to that of the beneficiary country, and that shares its financial resources, knowledge and expertise to help others do the same.~~

~~The pivotal and facilitating partners each report on the resources they provide.~~

- Two other partners (of which one is a SSC provider) that make their knowledge, expertise and/or financial resources available to help the beneficiary tackle the development challenge.

Each partner reports on the resources they provide. Roles can change throughout the lifespan of a project and all partners learn during the exchange.

4. Figure 4 would be updated accordingly:



5. Paragraph 122 that describes the framework of collaboration would be edited as follows:

- **TRIANGULAR CO-OPERATION** – Also referred as trilateral co-operation. A partnership involving at least three partners and where the following main roles can be identified:
  - a beneficiary partner that is a TOSSD recipient and that requests support to tackle a specific development challenge and;
  - ~~a pivotal partner that has relevant domestic experience in addressing the issue in a context similar to that of the beneficiary country, and that shares its financial resources, knowledge and expertise to help others do the same; and~~
  - ~~a facilitating partner, that helps connect the other partners, and supports the partnership financially and/or with technical expertise.~~
  - two other partners (of which one is a SSC provider) that make their knowledge, expertise and/or financial resources available to help the beneficiary tackle the development challenge.

Partners include countries (at national and sub-national levels), international organisations, civil society, private philanthropy, private sector and academia. ~~The pivotal partner is often an actor or institution from another developing country or from the same region as the beneficiary.~~ Joint programming, pooled funding or delegated co-operation should not be classified as triangular co-operation, unless the three roles are represented in the activity.

### III. Tracking multilateral organisations' support for South-South co-operation

6. Following the introduction of a filter by 'framework of collaboration' in the [tosssd.online](https://tosssd.org/) data visualisation tool, the Secretariat reviewed the consistency in the use of the South-South co-operation (SSC) code. It observed that the SSC code had been applied by multilateral organisations, while the description of the code in the Reporting Instructions specifically refers to collaboration among countries, with no mention of multilateral organisations.

7. At the May 2024 meeting of the IFT General Assembly, the applicability of SSC as a framework of collaboration for multilateral organisations was discussed. Opinions among participants varied. One participant viewed SSC as a framework of collaboration between governments, noting that multilateral organisations typically participate in triangular co-operation arrangements, as outlined in the language of BAPA+40. Another participant commented that the application of the SSC code to activities of multilateral organisations would require the development of new criteria, e.g. whether over 50% of the institution's financing comes from the South, and whether the institution's mandate is aligned with SSC principles. A representative from a multilateral institution explained that, as they operate in the South, they wished to report their technical assistance activities as SSC, but acknowledged the need for clear criteria to support such reporting. It was agreed that the Secretariat would further analyse the use of the SSC code by multilateral organisations and propose an alternative for discussion by the Steering Group.
8. The Secretariat consulted with the following multilateral organisations that currently report or wish to report on the SSC code: the Caribbean Development Bank, the Islamic Development Bank, the New Development Bank and the Organisation of American States. Based on their feedback and suggestions, the Secretariat proposes the creation of a new code specifically for multilateral support for South-South co-operation. The following description is suggested for inclusion in paragraph 122 of the Reporting Instructions and the TOSSD code list:

**FC03 Multilateral support for South-South co-operation:** Collaborative arrangement whereby a multilateral institution supports South-South co-operation exchanges, providing a mechanism or a structure that facilitates the exchange of knowledge, skills, expertise and/or resources among two or more developing countries.

#### **IV. Classification of core contributions to international organisations (multilateral organisations, international NGOs and PPPs) as either pillar II.A or II.B**

9. At its May 2024 meeting, the Steering Group approved edits to the Reporting Instructions regarding the split of pillar II into two sub-pillars, with the exception of the treatment of core contributions to international organisations. The classification of these contributions remains to be clarified, as specified in footnote 40 of the Reporting Instructions: "The International Forum on TOSSD is currently testing the delineation of core contributions to the multilateral system. The Steering Group will discuss and agree on a classification of organisations as Pillar II.A and II.B for inclusion in the Reporting Instructions. Pending agreement by the Steering Group, contributions to organisations that do not report to TOSSD are classified by default as Pillar II.B."
10. This section presents a proposal for the classification of core contributions to international organisations as pillar II.A or II.B. It includes multilateral organisations, Public-Private Partnerships (PPPs) and international NGOs.

##### **A. Classification of core contributions to multilateral organisations**

11. The Secretariat conducted an initial assessment of the classification of core contributions to multilateral organisations that report to TOSSD, which was shared with the Steering Group. (See Annex 1. Note that

organisations that report to TOSSD but lack a channel code will be assigned one to facilitate the tracking of contributions to them and to ensure there is no double counting with the outflows from the organisations.)

12. Regarding organisations that do not yet report to TOSSD but have a separate channel code, the Secretariat reviewed their mandates and proposed a classification of core contributions into sub-pillars II.A or II.B. This proposed classification is included in Annex 2 for review by the Steering Group. Once approved, the Secretariat will integrate the classification in the TOSSD code list, within the channel code tab.
13. For core contributions to multilateral organisations without a channel code, the Secretariat suggests that the classification is at the discretion of reporters who would assess whether the mandate and geographical focus of the Organisation addresses developing countries (pillar II.A) or has a more global reach (pillar II.B). As part of its data quality assurance work, the Secretariat would monitor any inconsistencies in the data reported by different providers and, if necessary, signal them to the relevant IFT body<sup>1</sup>.

## **B. Classification of core contributions to NGOs**

14. The Secretariat has reviewed existing channel codes for NGOs, which include donor-country-based NGOs, developing-country-based NGOs and international NGOs. Given the large number of NGOs and the diverse nature of their activities, the Secretariat proposes that each reporting country or institution make its own assessment on whether the core contribution should be classified as pillar II.A or II.B.
15. This assessment would depend on whether the institution primarily operates in developing countries or focuses on issues specific to developing countries (in which case the core contribution would be classified as pillar II.A), or whether they also work with non-TOSSD recipients or address matters of a regional/global nature not specific to developing countries (which would result in classification as pillar II.B).
16. At the end of the reporting year, the Secretariat will review the data collected and assess the consistency of classification across TOSSD reporters. Any major inconsistencies will be presented for discussion by the relevant IFT body.

## **C. Classification of core contributions to Public-Private Partnerships (PPP) and networks**

17. The Secretariat has reviewed existing channel codes for PPPs and networks in the TOSSD code list and conducted a light assessment of their classification by screening their websites and mandates. A proposed classification is included in Annex 3.
18. Additionally, the Secretariat proposes contacting the PPPs and networks that receive the largest contributions to invite them to report to TOSSD. In 2022 data, out of USD 5.4 billion of core contributions in total, the Coalition for Epidemic Preparedness Innovations received nearly one-third (USD 1.7 billion), while the International drug purchase facility received 14% (USD 759 million). Other

PPPs and networks that received more than USD 100 million in 2022 were the International Union for the Conservation of Nature, the International AIDS Vaccine Initiative and the Africa Finance Corporation. The classification as pillar II.A or II.B could then be updated, if needed, based on the data reported.<sup>2</sup>

## V. Complementing the guidance on ‘global health’ with additional examples of diseases prevalent in developing countries

19. At its May 2024 meeting, the Steering Group approved the insertion, in Annex E of the Reporting Instructions, of additional guidance on the eligibility of global health activities. The section in question features a box with examples of diseases prevalent in developing countries that were obtained from relevant lists of PAHO and the WHO.
20. Following further consultations on this topic, the Secretariat proposes adding a few examples to Box 1 of the Reporting Instructions based on the G-Finder project<sup>3</sup>, as follows (see underlining for new text, ~~striketrough~~ for deleted text):
